 with the completion and recording of necessary checks being carried out.


Departmental Information

The Design Technology department has two workshops and 2 classrooms, including an Apple Mac suite and benefits from connected storage facilities and preparation areas. There is a Head of Department and part-time DT/Art teacher.

Main tasks and responsibilities

Undertake and/or supervise the following tasks:

- Provision and preparation of resources and equipment for lessons within the department, including the construction of teaching aids (jigs, moulds, formers, etc).
- Liaise with the curriculum leader for design and technology to undertake the necessary ordering of items of stock, checking deliveries and ensuring suitable storage and record keeping.
- Maintain an inventory of stock and materials.
- Assist with administrative tasks e.g filing, photocopying and laminating across the faculty.
- Support students and teaching staff when doing practical tasks.
- Undertake routine maintenance of workshop equipment, including cleaning, calibration, testing, repair and removal from circulation of damaged or faulty equipment to ensure it is kept in good working order.
- Check and manage the extraction system on a regular basis.



- Arrange for the regular safety inspection of equipment from external contractors.
- Maintain a record of departmental risk assessments.
- Support school events such as set design and prop manufacture for school productions.
- Keep up to date with Health and Safety and COSSH regulations and ensure all staff in the Art & Technology Faculty are kept informed and oversee compliance by team members.
- Take part in CPD activities as appropriate.


